



## **EST Inception Meeting**

9-10 September 2004  
Hanoi, Viet Nam



### **1. Background**

While transportation is essential to Asia's socio-economic needs, balancing these needs with the need to protect the environment should be at the heart of the concept of environmentally sustainable transport (EST). Generally, EST is considered as transport that meets the needs of the present without preventing future generations from meeting their needs. Although there is no single, commonly held definition of EST, the concept of EST is centered on the transportation system and transportation activity that meets social, economic and environmental objectives.

The Manila Policy Dialogue on Environment and Transport in the Asian Region, held from 16-17 January 2004 in Manila, Philippines, helped translate recommendations made in relation to the transport and environment sector in the Johannesburg Plan of Implementation (JPOI) and the Nagoya EST Conference into actions at local, national, and regional level, by (i) looking into transport and environment related issues, with a priority focus to issues relating to monitoring of air quality, reduction of emissions from in-use vehicles, fuel quality, and environmentally friendly public transport planning; and (ii) making recommendations towards the promotion of EST in Asia, through the adoption of the Manila Statement.

In the Manila Statement, UNCRD was requested by participating Asian countries to assist them in (a) the formulation of National EST Strategies-cum-Action-Plans, and (b) the establishment of a Regional EST Forum and subsidiary expert groups. As a follow-up to the Manila Conference, UNCRD has initiated contact with relevant partners and stakeholders to formulate national strategies-cum-action plans for Viet Nam, Cambodia, and Laos, as the first phase countries. Preparations are also being made for the first Regional Forum meeting in August 2005.

### **2. Objectives**

The EST Inception Meeting will be the first country level stakeholders meeting, in which the formulation process for the National EST Strategy-cum-Action-Plan will officially commence.

The objectives of the EST Inception Meeting are to discuss and finalize:

- (a) the detailed work programme/activities/timeframe for the preparation of the National EST Strategy-cum-Action-Plan;
- (b) institutions to be involved in the process;
- (c) identification & role of Collaborating Centre
- (d) MoU/Agreement, including funding arrangements and generic guidelines towards formulation of the National EST Strategy-cum-Action Plan.

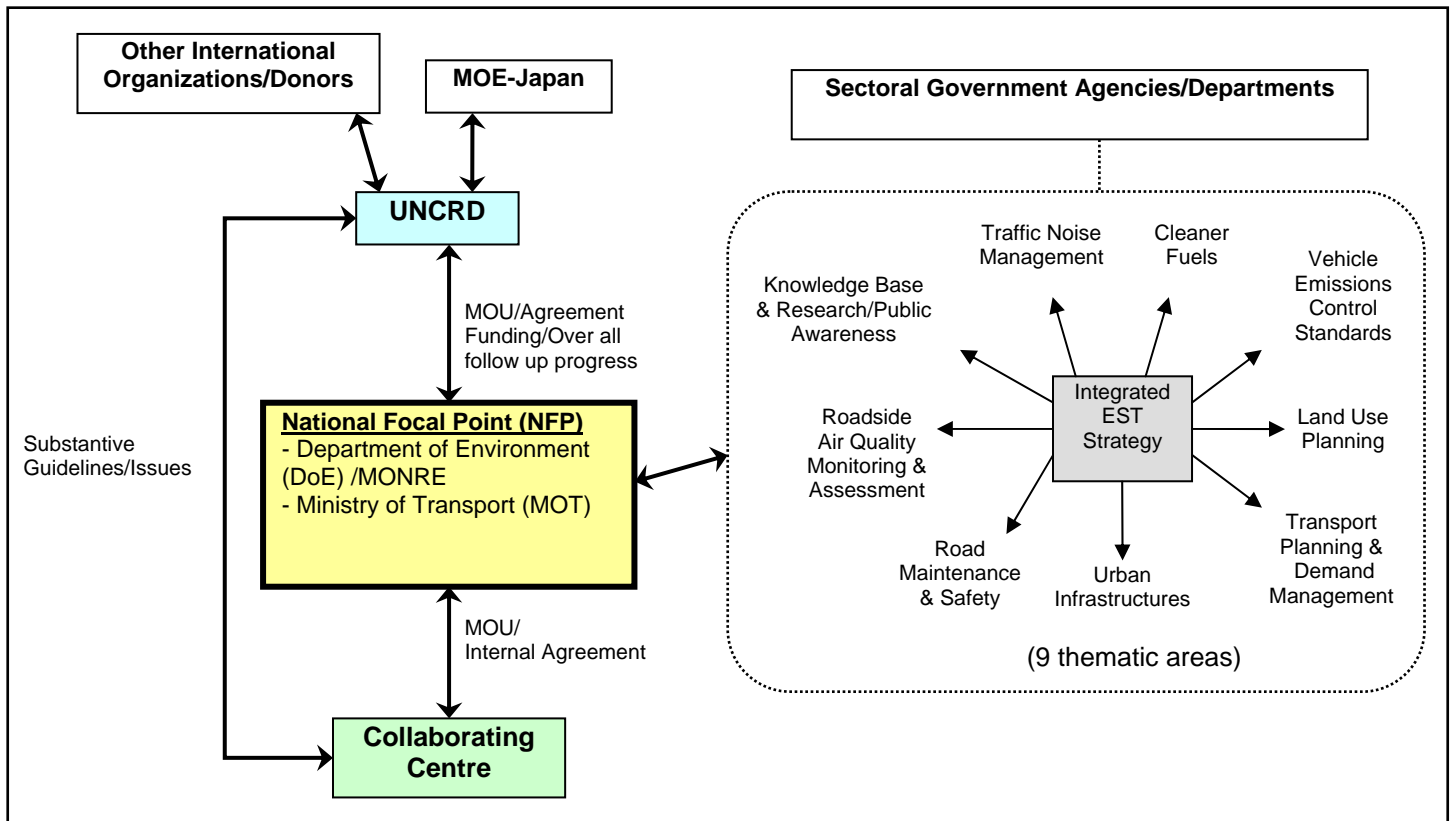

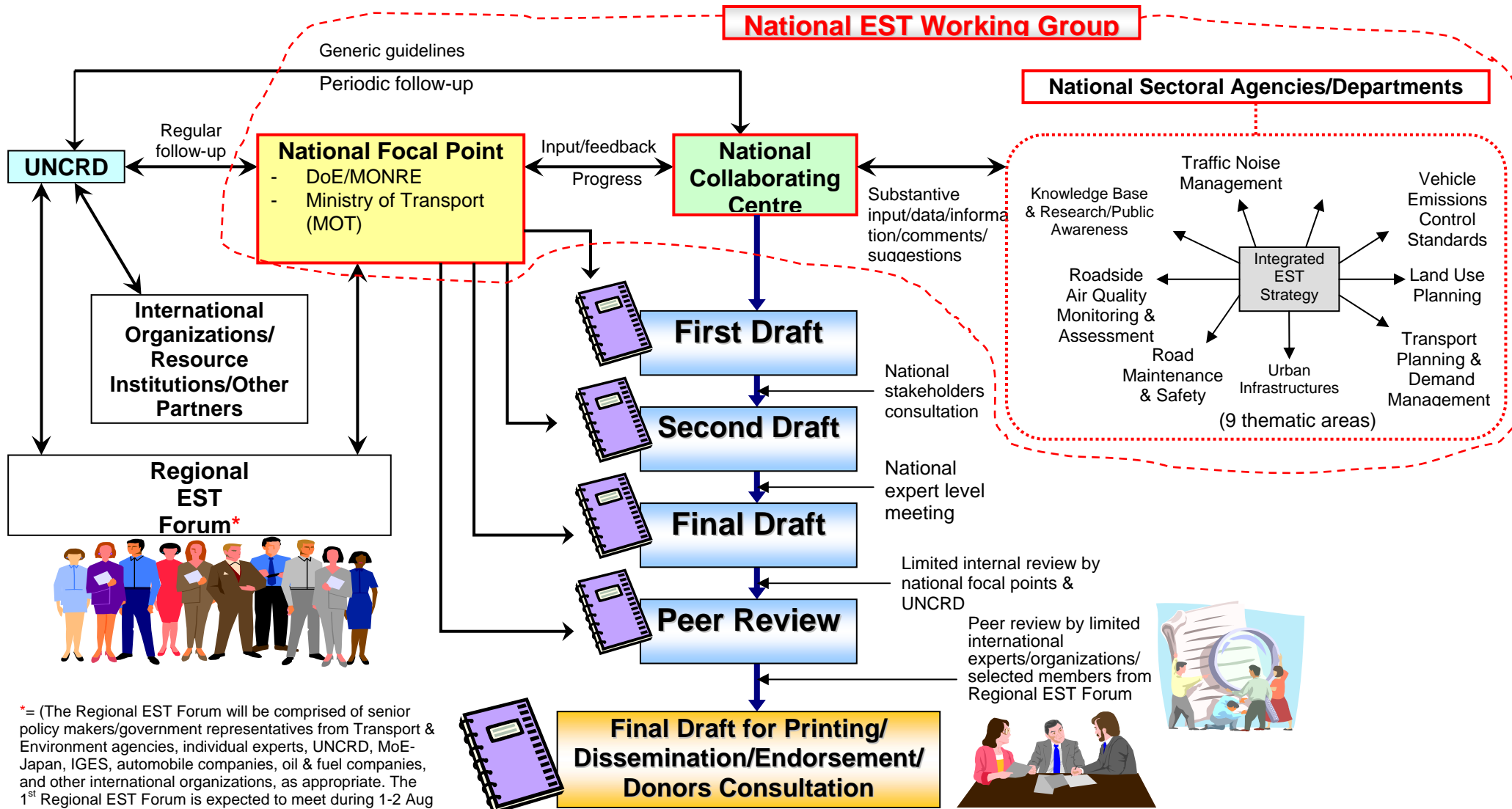
